The 50th Annual Mountain Fest will be held at Sabillasville Environmental School on Saturday, October 10th and Sunday, October 11th, 2025. Individuals, families, and organizations are encouraged to participate in merchandising home crafts, agricultural products, antiques, farmer's market, home party displays, etc. Domestic and farm animals are welcome to exhibits as are contained/controlled wildlife. Non-profit organizations are welcome to share their services in a booth type setting. Storytellers, theatrical groups, and living history exhibits are also invited. Encouraged activities for children such as craft making, organized games and face painting.

Exhibitor Details

The inside display area per exhibitor will be approximately 10x10. The display/booth area is assigned solely at the discretion of the Mountain Festival committee. The exhibitor must furnish all tables, tents, sound systems, and other necessary equipment. *The organization will not be responsible for theft or damage to exhibitor's goods.*

Booth/participation space is available by donation to the Sabillasville Environmental School Parent Teacher Organization. Your donation will fund the SES students' education and future. You are restricted from selling the following: Hot food, drinks (cider, coffee, soda, hot cocoa), sandwiches, soup, and fries. Exhibitors may sell homemade baked goods.

Hours of set-up

The school will be open Friday October 19th from 6PM to 8PM. Exhibitors may not enter the building before 8AM on either event day. Mountain Festival hours for the public are October 10th: 9AM to 5PM and October 11th: 9AM to 4PM. Please refrain from dismantling your display until 4PM, if possible.

Please Note

If a health department permit is required, it is your responsibility to obtain and display it in your area. It is your responsibility to obtain any liability insurance pertaining to your activities/exhibit at Mountain Fest. SES PTO is not responsible for accidents. Smoking, drugs, and alcohol on the school property are strictly prohibited.

Outdoor vendor space: \$40

The fee reserves the space for the entire event. All fees are nonrefundable unless the event committee terminates the event.
